Thank you for choosing Arizona Wedding Pastors to create and perform your wedding ceremony!

In selecting Arizona Wedding Pastors to officiate at your wedding you can expect:

- A complimentary preliminary get-acquainted and planning appointment with the Officiant who will create and perform your wedding
- Access to vows, ring vows, readings and unity ceremony ideas
- Unlimited phone & email correspondence to create your personalized ceremony
- Performance of your ceremony on time at the location of your choosing
- The printed version of your ceremony on keepsake quality paper
- First Class mailing of your completed marriage license to Maricopa County

STARTING TIME: Keep in mind that time constraints apply to the scheduling of your ceremony. On-time arrival is fifteen minutes before the scheduled ceremony time. The assigned Officiant may be scheduled to leave **forty minutes** after the starting time agreed upon above. He cannot linger and will not be late for another event following yours due to a late start time. Contact your Officiant immediately to check his availability if you consider changing your location, date or starting time. If for ANY reason (by no fault of the Officiant) the ceremony starts twenty minutes or more after it is scheduled, the Officiant may, at his option perform a very short civil ceremony in place of the agreed-upon ceremony. Your Arizona Wedding Pastors Officiant retains the right to edit anything and everything he is expected to read aloud in public, in order to insure proper decorum and professionalism.

TERMS: Upon signature of contract and receipt of \$100.00 nonrefundable deposit, your Officiant reserves your date & time (transferable). The balance is due 30 days before the ceremony and is nonrefundable from that time. Unpaid fees result in cancellation of services. A \$45.00 minimum returned check fee will be imposed for unfunded checks. In the event that your Officiant is prohibited from officiating at your ceremony as planned due to hospitalization, auto accident, transportation breakdown/disruption, traffic difficulties or other unforeseen incapacitation on the day of the ceremony, Arizona Wedding Pastors will make every attempt to provide for a substitute Officiant who can provide substantially the same level of service or provide a 100% refund. We have 5 Officiants available. I understand that my Officiant will maintain the original copy of this contract and that I will receive a copy for my files. I also understand that it is my responsibility to possess a valid marriage license in the state where the wedding ceremony will take place.
